



Abstract Submission Guidelines

1. All abstracts must be submitted online by **Monday, May 15th, 2024**.
2. Notification of abstract acceptance will be sent by e-mail by **Monday, July 15th, 2024**.
3. Abstracts must be written in clear English and presented in English.
4. Authors will be required to indicate their preferred presentation type (**Oral/Poster**) when submitting an abstract. While your preference is prioritized, the final mode of your presentation will be selected by the Scientific Committee.
5. The presenting author is allowed to participate in other abstracts as a co-author, but not as the primary author.

Title	<p>Not exceeding 15 words.</p>



<p>Authors (All types of Authors)</p>	<ul style="list-style-type: none"> List the primary author's full name, followed by the other authors' full names. Authors' information requested: Last name, First name, Affiliations, City, Country, Email address. (e.g. Yoocharoen, <i>Kwanchanok</i>, Department of Pediatric Dentistry, Srinakharinwirot University)
<p>Presenting Authors</p>	<ul style="list-style-type: none"> The presenting author is allowed to participate in other abstracts as a co-author, but not as the primary author. Presenting authors must register for the meeting through the website.
<p>Body of Abstract</p>	<ul style="list-style-type: none"> Please refer to the below, "Guidelines for Body of the Abstract." Not exceeding 250 words (title, author's names, and affiliation details are excluded)
<p>Keywords</p>	<p>3-5 keywords required</p>
<p>References</p>	<p>References are not obligatory; however, the word count is affected by the inclusion of references.</p>
<p>Participation in the Presentation Competition</p>	<p>Every author is eligible to participate in the presentation competition, categorized into 2 presentation types: Best Oral Presentation and Best Poster Presentation. The presenting authors must present their paper following the competition schedule on October 31st, 2024, in front of the assigned Scientific Judges. Those who fail to present their paper at the designated time will be put off from the competition.</p>



Guideline for Body of Abstract

Original Research Article/Systematic Review

They should include the following sections with headings, describing the research undertaken and the revealed outcome: **Objectives:** Usually one short simple sentence stating the objective of doing the study. **Methods:** This section must be clearly written and in sufficient detail for the work to be repeated by other scientists. The statistical methods used should be stated. Where needed, the FDI tooth notation system must be used. **Results:** These should be clearly and succinctly presented and only related to the methods described. Where needed, appropriate data should be given as to the reproducibility of the findings. Statistical analysis should be also included in this section. **Conclusions:** This should briefly outline the most important findings.

Case(s) Report

They should include the following sections with headings, describing the case(s) and treatment provided: **Introduction:** In this section briefly describe the background for the case report, introducing the topic that the case/technique addresses. Explain why this case is worthy of note. **Case operation / procedure:** This section should be the longest and most detailed part of the abstract. Relevant information should include patient(s) basic demographics, clinical findings, treatment plan and techniques used and the final outcomes. **Summary:** Includes the main “take-home” message from the report, indicating its significance and explaining the implications for clinical practice or future research.

Presentation Material	A Single Graphic File (.jpeg, .jpg, .png, .tiff), at least 3840x2160 pixels of resolution, will be the display screens in the Poster Areas; the presenting author is to stand by the poster.
Deadline of Presentation Material (Graphics) Submission	8:00 PM Tuesday, October 29th, 2024 (Bangkok time)



Awards for the Presentation Competition

- Best Oral Presentation (for all categories): US\$ 1000; US\$ 500 (First runner-up)
- Best Poster Presentation (for all categories): US\$ 1000; US\$ 500 (First runner-up)
